Contest Rules and Regulations

Open to legal residents of Canada (excluding Québec) who are of age of majority in their province/territory of residence at the time of entry. No purchase necessary. Purchase of any Rohit Communities home in Edmonton during the entry period qualifies for automatic entry.

- 1. **ENTRY PERIODS:** The 15K Giveaway Contest (the "Contest") mail-in entry period begins on August 1st, 2022 at 12:00:01 a.m. Mountain Time ("MT") and ends on August 31st, 2022 at 11:59:59 p.m. MT (the "Mail-in Entry Period"). The home purchase entry period begins on August 1st, 2022 at the start of regular business hours and ends at the close of regular business hours on September 15th, 2022 all deals signed after this date are no longer eligible. A home is not considered purchased until a minimum 5% deposit has been made, a bill of sale has been signed and all conditions have been met and removed. Any signed conditional deal by August 1st has until end of regular business hours on September 15th to meet and remove conditions (the "Home Purchase Entry Period"). Collectively, Mail-in Entry Period and the Home Purchase Entry Period shall be referred to as the "Entry Period."
- 2. **ELIGIBILITY:** Contest is open to all Canadian residents excluding residents of Quebec, who have reached the age of majority in their province/territory of residence at the time of entry, except employees, representatives or agents (and (i) their immediate family members and (ii) those with whom such persons are domiciled, whether related or not) of Rohit Group of Companies (the "Sponsor"), its parent companies, subsidiaries, affiliates, prize suppliers, dealers, advertising/promotion agencies and any entity involved in the development, production, implementation, or fulfillment of the Contest (collectively, the "Contest Parties"). Upon receipt of your Request during the Mail-in Entry Period in accordance with these Rules, including, without limitation, the Entry limits provided below, you will receive one (1) Entry. Requests received prior to the commencement of the Mail-in Entry Period will be counted as having been received on the first day of the Mail-in Entry Period. Requests received after the last day of the Mail-in Entry Period will be discarded. To be eligible, each Request must: (i) be received separately in an envelope bearing sufficient postage (i.e. mass mail-in Requests in the same envelope will be void) or hand delivered; and (ii) be received by no later than August 31st, 2022; Your Request will be time-stamped based on when it is received by the Sponsor (i.e. not when it is post-marked). The Released Parties (defined below) take no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed Requests (all of which are void).

- 4. **ENTRY LIMIT:** There is a limit of one (1) Mail in Entry per person during the Entry Period and one (1) Automatic Entry resulting from the purchase of a home, depending of the method of entry. If it is discovered by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to: (i) obtain more than one (1) Entry during the Entry Period; and/or (ii) use multiple names and/or identities to enter or otherwise participate in or disrupt this Contest; then he/she may be disqualified from the Contest in the sole and absolute discretion of the Sponsor. The Released Parties (defined below) are not responsible for late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void).
- 5. **VERIFICATION:** All Entries, Requests, Eligible Purchases and entrants are subject

- to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of an Entry, Request and/or Eligible Purchase for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules.
- 6. Failure to provide such proof to the complete satisfaction of the Sponsor in a timely manner may result in disqualification in the sole and absolute discretion of the Sponsor. The sole determinant of the time for the purposes of a valid Entry, Request and Eligible Purchase in this Contest will be the Sponsor's clock.
- 7. THE PRIZES AND APPROXIMATE RETAIL VALUE: There will be a maximum of one (1) prize available to be won. In the event of a confirmed winner who has submitted his or her winning entry automatically with the purchase of an Eligible Home or via mail in entry, the applicable Prize consists of a cheque payable to the confirmed winner in the amount of \$15,000 (inclusive of applicable fees and taxes). Each Prize must be accepted as awarded and is not transferable or assignable (except as may be specifically permitted by Sponsor in its sole and absolute discretion). - 8. **WINNER SELECTION (ONE WINNER) AND ODDS OF WINNING:** At the end of the Contest Entry Period (August 31st, 2022 for mail-in, September 15th, 2022 to remove conditions) the Sponsor will collect all legitimate mail-in submissions and all single family purchase submissions. The draw date is to take place before October 1st, 2022 (the "Draw Date"), in Edmonton, AB at approximately 10:00am MT, one (1) eligible entrant will be selected by random draw (a "Draw") from among all eligible Entries submitted and received during the Contest Entry in accordance with these Rules and not otherwise disqualified by the Sponsor. Entries that are not selected will no longer be eligible for reward. The odds of winning depend on the number of eligible Entries submitted and received during the Contest Entry Period in accordance with these Rules.
- 9. **WINNER NOTIFICATION:** On the Draw Date, the Sponsor or its designated representative will make three (3) attempts to contact the entrant selected on the Draw Date by telephone (using the information provided at the time of entry) within the 48 hours immediately following the draw. If the selected entrant cannot be contacted as indicated above; then he/she may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to the

applicable Prize) and the Sponsor reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate eligible entrant from among the remaining eligible Entries in the applicable Draw (in which case the foregoing provisions of this section shall apply to such newly selected entrant, with the necessary amendments).

- 10. WINNER CONFIRMATION: BEFORE BEING DECLARED A CONFIRMED

- 12. The Released Parties will not be liable for the failure of any Entry, Request, Eligible Purchase or other information to be received, captured or recorded for any reason, including weather, mail delivery disruption or unavailability, telephone service disruption or unavailability, strikes, lockouts, or any labour dispute at Rohit Communities or other organization or business. Each confirmed prize winner is solely responsible for reporting and paying any taxes, if applicable, relating to the receipt of a Prize.
- 13. The Sponsor reserves the right to withdraw, amend or suspend this Contest (or to amend these Rules) in any way, in the event of an error, problem, tampering, unauthorized intervention, fraud, failure or any other cause that interferes with the proper conduct or administration of this Contest as contemplated by these Rules. Any attempt to undermine the legitimate operation of this Contest in any way (as determined by the Sponsor in its sole and absolute discretion) is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law. The Sponsor reserves the right to cancel, amend or suspend this Contest, or to amend these Rules, in any way without prior notice or obligation in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever that, in the sole discretion of the Sponsor, is required to preserve the integrity of the Contest. Without limiting the generality of the forgoing, the Sponsor reserves the right, in its sole and absolute discretion, to administer an alternate test of skill as it deems appropriate based on the circumstances and/or to comply with applicable law.
- 14. Without limiting the permissions to be granted to the Sponsor pursuant to paragraph 9 of these Rules, by entering this Contest, each entrant expressly consents to the Sponsor, its agents and/or representatives, storing, sharing and using the personal information submitted for the purpose of administering the Contest.
- 15. The Sponsor reserves the right and, otherwise, without prior notice, to adjust any of the dates and/or timeframes stipulated in these Rules, to the extent necessary, for purposes of verifying compliance by any entrant, Entry, Request and/or Eligible Purchase with these Rules, or as a result of any technical or other problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Contest as contemplated in these Rules, or for any other reason.
- 16. In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any Contest-related

- materials, including, but not limited to point of sale, television, print or online advertising; the terms and conditions of these Rules shall prevail, govern and control to the fullest extent permitted by law.
